Friends of Buddina is a local community group located in the Kawana Waters district of the Sunshine Coast. We appreciate the opportunity provided by the Games Independent Infrastructure and Coordination Authority to participate in the community consultation process for the 2032 Olympic and Paralympic Games infrastructure and planning.

This submission refers only to the proposed *Sunshine Coast Indoor Sports Centre* and the proposed location of that infrastructure.

Sunshine Coast will host some *preliminary* basketball matches during the first week of the 2032 Olympic Games, with the *major and final* basketball events being played in Brisbane at the proposed redevelopment of the Albion Park Paceway, also subject to the 100 Day Review.

The designated location for Sunshine Coast *preliminary* basketball Olympic 2032 matches was initially proposed to be hosted at the new Sunshine Coast Exhibition and Convention Centre, at Maroochydore in close proximity to the Athletes . Without public consultation, "other vested interests" altered this proposal and directed that when funding became available, it was to be redirected to constructing an Indoor Sports Centre at Kawana/Bokarina on the southern side of the Mooloolah River.

Friends of Buddina do NOT SUPPORT the proposal for an Indoor Sports Centre at Kawana/Bokarina.

Friends of Buddina SUPPORT an alternative Sunshine Coast location, at Maroochydore, for the Indoor Sports Centre to host the *preliminary* basketball matches during the 2032 Games.

Friends of Buddina believe that the most appropriate location ought to be one that:

- 1. does not displace existing sporting bodies, their history, their players and their supporters;
- 2. does not sacrifice or isolate one high-profile sporting code to provide for another sport;
- 3. does not result in the loss of playing fields and the scarce green space that the fields provide;
- 4. does not have other negative impacts on local residents and the community;
- 5. supports a multi-purpose built-form utilised for sporting and other events and exhibitions;
- 6. located within 500m walking distance of public transport (either rail, bus or preferably both);
- 7. located nearby the Athletes Village;
- 8. located nearby multiple options for tourist and other visitor accommodation;
- 9. located to support equitable geographic distribution of indoor sporting facilities

Accordingly, we request that the *Games Independent Infrastructure and Coordination Authority* reconsider the location assigned for investment in the Sunshine Coast Indoor Sports Centre based on a balanced assessment of financial and community impacts, including those outlined in the comparison table provided below:
